## Collection of your Personal Information

VCI gathers publicly identifying information, such as your e-mail address, name, home or work address, phone number, for the purpose of registering your data as a member of VCI, a contact individual from a group of VCI, or as a participating member for an event organised by VCI. In addition, when you make a donation on the website, we will also require your credit card number. VCI also automatically collects details about your computer hardware and applications. Your IP address, browser version, domain names, access times, and referencing Web site addresses are examples of this detail.

The details you provide will only be shared with third parties who are required to process your donation. We will take appropriate steps to avoid the deletion, abuse, or modification of any information you provide us. VCI's agents and contractors who have access to the information you provide us in the process of delivering services to us are obliged to keep the information confidential and are not allowed to use it for any reason other than carrying out the services that they are doing for us.

## How do we collect your data?

## How will we use your data?

VCI gathers and uses your personal information to run VCI and RunToFeed Web site to provide you with the services or information you have needed. Your personally identifying information is VCI/ RunToFeed through its main website ([www.venezuelancommunity.ie](http://www.venezuelancommunity.ie)) or partner websites .VCI records the Web sites and pages that our clients access on our website in order to decide which resources are most commonly used. - The right to data portability - You have the right to request that VCI transfer the data that we have collected to another organization, or directly to you, under certain conditions.
